Major research interests:

On the broadest level, I am interested in political transitions, particularly in developing countries, and most notably in Africa. My publications have come in the areas of African politics, human rights and civil-military relations.

My research for the past several years involves the effectiveness of human rights non-governmental organizations. As key parts of civil society, NGOs have become central to the promotion and protection of human rights. I document this in several books, five already published (*Human Rights and Development in Africa*, 1984; *Human Rights in Asia*, 1990; *Protecting Human Rights in Africa: Strategies and Roles of Non-Governmental Organizations*, 1995 (paperback 2001); *NGOs and Human Rights: Promise and Performance*, 2001; and *Economic and Social Rights in Canada and the United States*, 2006 (paperback 2009). Three chapters of a projected book, *Protecting Human Rights Globally: Strategies and Roles of International NGOs* were published in *Human Rights Quarterly* as articles.
